WIS ADDENDUM TO SCHOOL FEES – SEPTEMBER 2024

Dear Parent/Guardian

Due to the current economic climate and as part of the school's annual review of terms & conditions, we would like to inform all parents that from September 2024, whole school monthly tuition fees will be invoiced in accordance with the table below.

Cohort	Tuition fees €
Primary 1- Sparrows	€ 552
Primary 2- Robins	€ 552
Primary 3- Owls	€ 578
KS3	€ 600
KS4	€ 615
AS/A2 level	€200 per subject. (English, Maths, Spanish, Business Studies)

Please note that this is only the second increase in 4 years and reflects fees which are still very competitive.

Consolidating information:

1. The **registration fee** for all new students will be a one-off payment of €600 per student
2. A non-refundable **enrolment fee** of €600 will be made at the time of registration.
3. A General **Resource, School Planner and Microsoft License fee** for €340 will be invoiced annually and must be paid by the 1st of June each academic year. (Includes White Rose maths provision & workbooks for Secondary/Primary, plus English SPaG and Spanish workbooks for Primary)
4. A cohort/age-appropriate ISBN booklist for KS3/KS4 will be issued to parents by 1st June each academic year for purchase of the required textbooks ready for the start of the new Autumn Term in September.
5. For current students, a **holding enrolment fee** of €200 must be paid by 01st June each academic year, to secure a placement for September. *(This will be deducted from your September monthly fees)*
6. If you do not wish your child to return in September, please give notice by 01st June 2024 via email to y.wilson@willowinternationalschool.es

If the school does not receive withdrawal notice, we will presume that your child will be returning in September 2024 and you will be automatically invoiced. Due to an increased waiting list, it is very important that we have the correct information regarding our September intake. This information must be processed by the school each year and submitted to the education authorities. This is a very time-consuming process and it is therefore imperative, that we have all the correct information in a timely fashion.

WIS continues to provide an excellent education in a warm and friendly environment, priding ourselves on small classes. We have recently had our second OfSTED Inspection on the 21st and 22nd of March with some outstanding features. The report will be available on our website soon. We gained a Good with Outstanding features on our initial inspection in 2022 and are one of the only schools to achieve this at such an early stage after opening in 2020. We are also proud to be ranked in the top ten schools on the national school's database.
